

The mission of Northern New Mexico College is to ensure student success by providing access to affordable, community-based learning opportunities that meet the educational, cultural, and economic needs of the region.







High School Equivalency Program (HEP)	80 students	NNMC's HEP ranked the best in the nation for 2016 and 2017 and was the 3rd highest among 48 HEP programs in 2018. In 2019 NNMC's HEP achieved an 90% graduation rate (national target being 69%). One- hundred percent (100%) of NNMC HEP graduates entered postsecondary education or training, upgraded employment, or entered the military (national target being 80%)



Credit Enrollment







Ethnicity Distribution Fall 2020







